An update on the CSP review and the draft Terms of Reference was provided. The following summarises the discussion:

- i. It was highlighted that a revised Terms of Reference was being drafted following the CSP review. Membership and aims remained the same and a good attendance at meetings was beneficial to the partnership overall. The draft Terms of Reference, the Partnership Strategic Assessment and the Community Safety Partnership Plan would be circulated prior to the next meeting of the CSP in January 2023.
- ii. It was advised that the Terms of Reference should be flexible and not overly specific. This would support the work of the CSP because a restrictive Terms of Reference would mean that partners were unnecessarily confined to particular courses of action.
- iii. It was recognised that the Community Safety Partnership was a strong and influential voice in Charnwood and it was suggested that this be used where appropriate in order to overcome issues.
- iv. There was a discussion around suicide prevention and the group discussed partnership working initiatives which could help to reduce the number of attempted suicides in the Borough. The number of attempted suicides was considered to be significant by the partnership and there was a need to reduce this. It was suggested that there was often a specific cause associated with suicide attempt cases, such as poor mental health or substance misuse. The partnership was not aware of what was being done to reduce suicide attempts, although it was suspected that work was being done by other groups. There was a suggestion that a representative from a mental health service within Charnwood be invited to attend meetings of the CSP in order to increase the information available to the CSP. Lindsay Widdowson agreed to identify an appropriate delegate from a mental health service to attend CSP meetings.
- v. The significant role of the Fire Service and the Police as first responders in suicide prevention cases was discussed. It was suggested that representatives from these partner agencies attend the Charnwood Health and Wellbeing Partnership meetings. Lindsay Widdowson agreed to liaise with partners and the Chair of the Charnwood Health and Wellbeing Partnership.
- vi. Turning Point was undertaking a pilot on 'dual diagnosis' clients (clients with multiple issues such as substance misuse and mental health problems). The pilot was funded until March 2023, at which point Turning Point hoped the pilot would be extended or additional funding could be secured, although this was not a certainty. It was agreed that an update be provided to subsequent meetings on the pilot being undertaken.

## **AGREED**

4. That Lindsay Widdowson arrange for Rob Kitson and Insp Dave Stokes to attend the Charnwood Health and Wellbeing Partnership.

## 6 2022/23 PERFORMANCE (Insp Dave Stokes)

A presentation detailing Charnwood performance figures was provided. The following summarises the discussion:

- i. The followings crime types had increased in comparison to the same period in 2021/22; Total Crime (+4.9%), Burglary – Residential (+14.7%), Burglary – Business and Community (+109.8%), Theft from Motor Vehicle (+73.8%), Theft of Motor Vehicle (+76.2%) and Anti-Social Behaviour Incidents – Storm Data (+0.2%).
- ii. The following crime types had decreased in comparison to the same period in 2021/22; Robbery (-11.1%), Cycle Theft (-20%), Violence Against the Person with Injury (-10.6%) and Sentinel Reports for Anti-Social Behaviour Incidents (-59.6% mainly due to a change in types of ASB recorded through Sentinel)
- iii. The new NPA Commander, Insp Dave Stokes was now in post and was keen to work on the reduction in crime figures. There were plans in place in order to encourage the reduction in crime, including the intention of creating a bespoke proactive team in Charnwood, further crime analysis actions being undertaken and better use of CCTV systems in place in the area.
- iv. The Burglary – Residential increase was considered to be due to the end of lock down periods as there were fewer people at home and therefore fewer deterrents.
- v. It was anticipated that crime figures may increase over the coming months due to the current cost of living crisis. The Police were prepared for this and would be working to proactively overcome this.
- vi. There had recently been a National County Lines Intensification Week which had been successful in Charnwood. It was highlighted that in Charnwood there would be greater significance placed on overcoming crime associated with County Lines in the future. This work is ongoing and will not just be targeted for specific weeks.
- vii. There was a discussion around anti-social behaviour in and around pubs in the Town Centre. There was currently an intensive education programme aimed at the staff in specific venues which had been

affected by anti-social behaviour, in order to support them to overcome issues in the future.

**AGREED** that the information be noted.

7 CSP STRATEGIC GROUP UPDATE (Alan Twells)

An update on CSP Strategic Groups matters was provided and the information in the report was outlined.

- i. It had been identified that businesses would benefit from proactively preventing crime, rather than experiencing crime and then reacting. It was suggested that Giuseppe Vassallo and Ioni Ashford liaise regarding training available to local businesses to prevent crime.

- i. The number of clients with alcohol dependency had increased significantly and was continuing to increase month on month.

There was no update provided by the Violence Reduction Network.

An update on Loughborough Students Street Support Scheme and Loughborough University matters was provided. The following summarises the discussion:

- i. Dates for the Student Street Support Scheme had been set out for the upcoming year.
- ii. Weekly ASB meetings with Charnwood Borough Council were continuing.
- iii. Spiking incidents had decreased from the previous year.
- iv. Proactive measures were being undertaken in order to reduce anti-social behaviour.

15 POLICE AND CRIME COMMISSIONER UPDATE (Sajan Devshi)

There was no update provided by the OPCC.

16 LEICESTERSHIRE FIRE AND RESCUE SERVICE UPDATE (Rob Kitson)

An update on Leicestershire Fire and Rescue matters was provided. The following summarises the discussion:

- i. Leicestershire Fire and Rescue Service were planning to issue 'Winter Warming Packs' over the winter months in order to support vulnerable



residents during the cost of living crisis. Any possibility of match funding was welcomed. It was highlighted that whilst this initiative would be beneficial to members of the community, it was not associated with crime and therefore the CSP was not able to provide match funding. It was suggested that Rob Kitson liaise with Verity Graham at Charnwood Borough Council in order to identify possibilities of support through match funding.

- ii. It was highlighted that much of the work being undertaken by Leicestershire Fire and Rescue Service was in line with the CSP Plan and that it would be beneficial to include details of this work in the plan.

**AGREED** that the information be noted.

17 NHS UPDATE (Lindsay Widdowson)

An update on health matters was provided. The following summarises the discussion:

- i. The Charnwood Health and Wellbeing Partnership had recently been formally established. It was recognised that the work of this group could be beneficial to the CSP.
- ii. A Charnwood Health and Wellbeing Plan was being established to identify the main focus of work and a workshop was being planned to facilitate this.

**AGREED** that the information be noted.

18 ANY OTHER BUSINESS

## Terms of Reference

### Context

The Charnwood Community Safety Partnership (CSP) is the statutory community safety partnership body required under the Crime and Disorder Act 1998 and subsequent legislation and is accountable for all statutory duties placed on Community Safety Partnerships

### Purpose

The CSP is a partnership group which is responsible for delivering the outcomes in the Community Safety Plan which relate to the prevention and reduction of crime, fear of crime, anti-social behaviour, harm caused by drug and alcohol misuse, reduction in violence and reoffending.

### Overarching Aim

'To deliver enhanced partnership working, collaboration and collective problem solving.'

### Principles

The following principles will guide the CSP's work:

- Balance risk and harm in relation to offenders, victims and communities
- Maximise and target resources
- Share information effectively
- Build on proven interventions
- Integrate offender management
- Monitor and evaluate progress against the CSP Plan, applying good practice at all times
- Facilitate effective community involvement
- Seek long-term community-based solutions for areas identified by the Partnership.

### Responsibilities

- Ensure compliance with national guidance and legislation relating to crime, disorder, substance misuse and reducing reoffending. This includes new legislation as it emerges.
- To ensure that Partnership Strategic Assessments are undertaken annually.
- To consider the Partnership Strategic Assessment and agree strategic priorities, objectives, and targets for the three-year Partnership Plan, which will be updated annually.
- To meet the requirements of the Domestic Violence, Crime and Victims Act (2004) as amended and statutory guidance in relation to undertaking Domestic Homicide Reviews (DHR's).
- To have cognisance of the need to take a multi-agency public health approach to tackling and preventing serious violence at a local level.
- To translate high level strategic priorities into local action plans for delivery (through sub groups, to be established by CSP) and resource deployment on either a 'places' or themed basis.
- To evaluate and monitor the performance of crime and disorder within the Borough and approve any action required to tackle areas of poor performance.
- To maximise and manage funding that is received and ensure that they are managed effectively, efficiently and with propriety.
- To endorse the evaluation of relevant projects that the CSP has funded.

### Membership and Voting

The membership of the CSP consists of core members who represent the responsible authorities under legislation and invited members. These core members have voting rights in relation to the CSP Plan and any partnership funding decisions.

### **Accountability and Governance**

Meetings will be held on a quarterly basis, with meeting dates set a year in advance.

Members of the group retain responsibility for meeting their individual statutory duties and responsibilities. Active engagement, co-operation and collaboration is a requirement of all Members.

There will be a collective and shared responsibility across all statutory partners to support and facilitate the work of the CSP.

The agenda and supporting papers will be circulated at least seven days before the meeting and late reports will only be taken with permission from the Chair.

The CSP will report to a Borough Council Scrutiny Committee annually, who will scrutinise and review the work undertaken by the Partnership.

Meetings of the CSP will be open to members of the public, however, exempt items may be taken that exclude members of the public and press.

### **Attendance**

If a representative of a statutory agency is unable to attend, a substitute must be sent to the meeting. Where attendance is not possible an update report will be submitted. If there is no representation for 2 meetings the organisation will be asked to re-appoint/confirm its commitment to the partnership.

### **Voting**

Whenever possible, all decisions will be made on the basis of consensus, with a casting vote held by the Chair.

A quorum of 33% of the membership is required for any decisions made by voting.

### **Chairing Arrangements**

The Chair will be the Cabinet Lead Member for Community Safety (or another Borough Council Elected Member nominated by the Lead Member for Community Safety – where this is the case both will have voting rights) and the Vice Chair will be elected annually.

The Chair has specific responsibilities in relation to DHRs as set out in the relevant statutory guidance.

The Chair will be expected to represent the CSP at events where appropriate.

The Chair will ensure that new representatives or members of the Board understand the roles and responsibilities and terms of reference, and the role that their organisation has agreed to play in the delivery of the CSP Plan.

In the absence of both the Chair and the Vice Chair, the members may appoint a temporary Chair for a meeting.

### **Review**

These terms of reference will be reviewed every 3 years, in line with the CSP Plan or if any significant legislation changes that requires amendments to ensure they are encouraging effective working, transparency, accountability, and good governance.

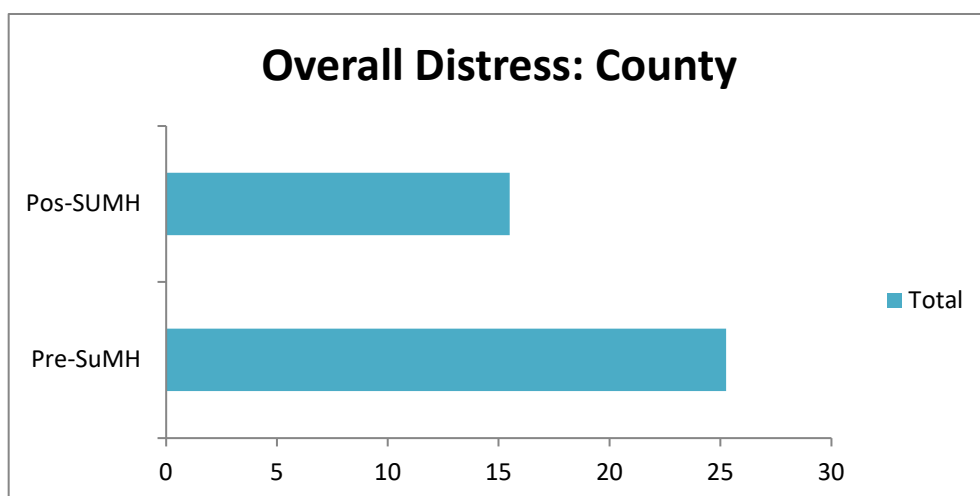

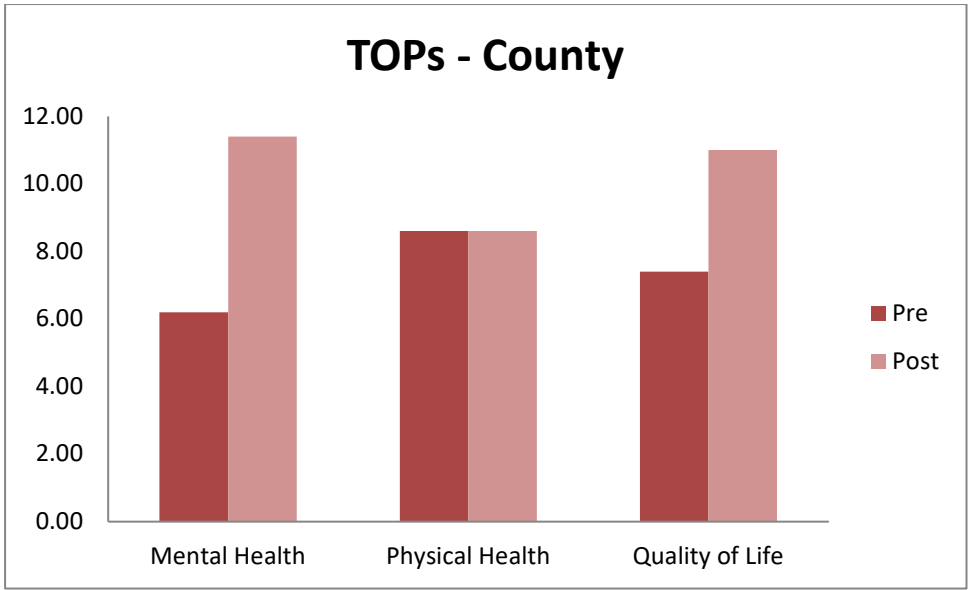

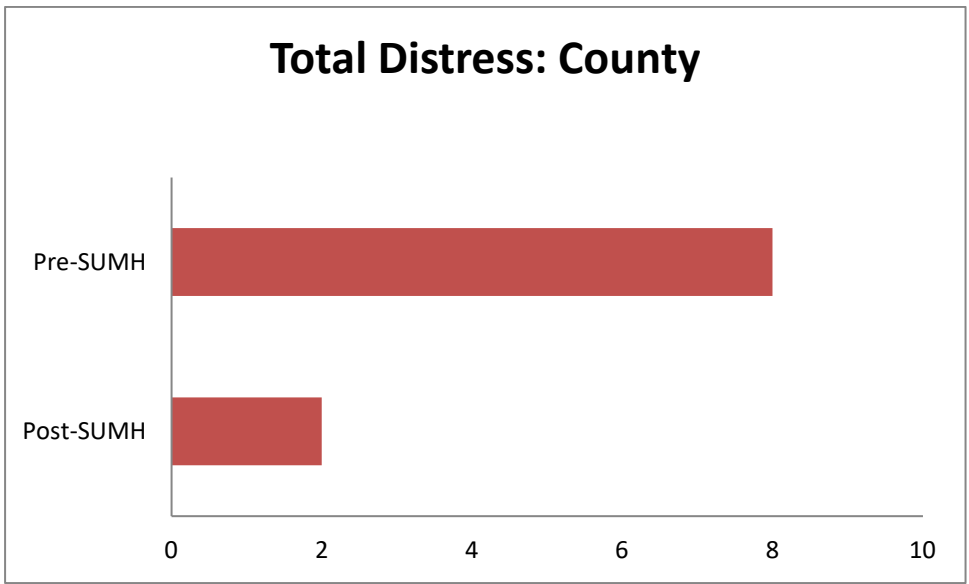
