ITEM 10 CONTAIN FUNDING

Purpose of Report

To advise Cabinet of the grant received by the Council through the Contain Outbreak Management Funding allocation and seek endorsement of the spending so far and future commitments for the funding.

Recommendations

- 1. That Cabinet note the allocation of Contain funding from Government via Leicestershire County Council.
- 2. That the spending proposals and commitments for funding be endorsed and supported by Cabinet.

Reasons

- 1. To ensure that Cabinet is aware of the details of the funding
- 2. To ensure Cabinet support the projects and proposed spend

Policy Justification and Previous Decisions

The funding was allocated by Government through the Contain Outbreak Management Fund to Leicestershire County Council. The COMF provides funding to local authorities in England to be used for test, trace and contain activity to reduce the spread of coronavirus in their area and to support local economies and public health.

Leicestershire County Council received £17.8 million, and of this 15% has been allocated to the district/borough council's, based on population size and deprivation factors. This is the methodology used for the Defra Emergency assistance grant earlier this year.

Leicestershire County Council approved allocations to each District/Borough Council, with Charnwood receiving £812k to be spent in 2021/22 to cover specific activities based on spend critera within the Government guidance. To date £93k has been spent, 11% of the funding, however the full amount is committed across the 5 service areas tabled in the summary shown in Part B of this report. All spending needs are in accordance with Government guidance.

There were 5 phases of LCC funding and each spend proposal has been submitted to Senior Leadership Team (SLT) for approval by Heads of Service. Subsequently the spend proposals were approved by Leicestershire County Council.

There are no proposals at this stage for further allocations of Contain Funding from the Government.

Part B

Background

The Contain Outbreak Management Fund (COMF) provides funding to local authorities in England to be used for test, trace and contain activity to:

- reduce the spread of coronavirus in their area
- support local economies and public health

Following the move to local COVID alert levels, as of 12 October 2020, local authorities were eligible for payments from the Contain Outbreak Management Fund to support proactive containment and intervention measures.

Payments were made to either upper or lower tier authorities in line with the policy in place at the time. In Leicestershire the payment was made to Leicestershire County Council, which then made allocations to each of the District and Borough Council's in the County.

The Contain Outbreak Management Fund supports work which increases engagement with control measures. It can also fund work in the recovery from the pandemic, including reducing the impacts of lockdown on businesses and communities.

There is no minimum or maximum funding limit. However, proposals must be aligned to the following COMF criteria, which allows funding of the following activities:

- a. Targeted testing for hard-to-reach groups out of scope of other testing programmes
- b. Additional contact tracing
- c. Enhanced communication and marketing e.g. towards hard-to-reach groups and other localised messaging
- d. Delivery of essentials for those in self-isolation
- e. Targeted interventions for specific sections of the local community and workplaces
- f. Harnessing capacity within local sectors (voluntary, academic, commercial)
- g. Extension/introduction of specialist support (behavioural science, bespoke communications)
- h. Additional resource for compliance with, and enforcement of, restrictions and guidance

- i. Measures to support the continued functioning of commercial areas and their compliance with public health guidance
- j. Funding Military Aid to the Civil Authorities (marginal costs only)
- k. Targeted support for school/university outbreaks
- I. Community-based support for those disproportionately impacted such as the BAME population
- m. Support for engagement and analysis of regional areas to assess and learn from local initiatives
- n. Providing initial support, as needed, to vulnerable people classed as Clinically Extremely Vulnerable who are following tier 3 guidance
- o. Support for rough sleepers.

Funding Allocations

LCC received a total £17,754,754 Contain Funding which it allocated 4.573% to Charnwood Borough Council on the following basis.

Phase 1 £310k up to Nov 2020

Phase 2 £117k Dec 2020

Phase 3 £117k Jan 2021

Phase 4 £117k Feb 2021

Phase 5 £151k March 2021

Total £812k, LCC Contain Funding received in 2020/2. £23,591 was spent in 2020/21 (Funeral costs £14,254k, Bed & Breakfast costs £9,337k) and £69,806 in 2021/22)so far, the detailed spend is shown in the table below.

The following projects /activities below are supported by the funding. All proposals were considered by SLT prior to the spending being approved.

Summary of Projects

Compliance and Enforcement – £211k

The funding is allocated and planned to be used on business support, advice, compliance and enforcement work during the road map Steps 1-3 and then Step 4 for recovery advice, support, any on-going controls and dealing with any outbreaks, in particular varirants of concern. The allocation is planned to be used from April 2021 – December 2021, with flexibility to extend or change as necessary.

Environmental Health Officers

Environmental Health Officers are undertaking COVID secure businesses checks, responding to complaints, investigating outbreaks within the Borough, reviewing event risk assessments and providing updated advice and enforcement as

necessary. Additional 'Health & Safety Executive Spot Checks' also continue and are being co-ordinated by Regulatory Services.

The High Street Helpers

Their main role is to gain the confidence of residents and visitors to return to the town centre for retail and other services. They are the 'eyes and ears' on the High Street and in open spaces providing guidance on current legislation in relation to COVID. They support public safety and business recovery gathering information about any issues observed and escalate where necessary and note on a daily report. Moving forward the High Street Helpers will have a role to play is supporting any gathering on planned events.

The Ambassadors

The Ambassadors act on intelligence and issues raised and are more task orientated than the High Street Helpers. They are given specific tasks or requested to visit and assist business to help them improve and compile while making sure that they have up to date guidance. They also provide regular reports and findings to support specific project or improvements.

COVID Support Stewards

These are employed via an external stewarding company and have a key role in gaining the confidence of the hospitality industry and the people who visit cafés, bars, restaurants and pubs. They help to ensure good compliance with legislation and guidance related to COVID is observed and maintained. They systematically visit individual premises while they are open to the public in the weekend evening hours to observe and provide guidance. The stewards have been well received and welcomed by businesses who have been keen to convey the COVID measures they have in place to keep the public safe

The funding which is split across a number of activities is summarised as follows:

- 1. £33k Agency Environmental Health Officers for min 37 hours per week on COVID investigations, complaints, advice and enforcement.
- 2. £34k Food Safety Managers additional hours on COVID work.
- 3. £63k Additional Environmnetal Health Officer hours seconded onto COVID outbreak, business advice and support, complaints, events and related work. (Will facilitate back-filling on Food Safety Inspection & Enforcement)
- £14k Additional 22 hours admin support for outbreak and compliance/enforcement support.
- 5. £35k External 'Covid Support Stewards' to be deployed during the 'Road Map Steps' to cover events, cafés, restaurants, pubs and hospitality sector as necessary.
- 6. £17k 'Businesses Support Ambassador' to support business compliance and recovery.
- 7. £11k Casual 'High Street Helpers' to assist in specific locations, events, open spaces and High Streets as necessary.
- 8. £4k Posters and communication materials to support compliance work.

The Contain Outbreak Management Fundspend to date on compliance and enforcement is £31,856, which has been spent across all the activities detailed above. From November 2020 – March 2021, the MHCLG Compliance and Enforcement Grant was used to support this work.

Community Hub support - £15k

Funding for additional officer hours to continue the support for Charnwood Community Action.

Community Hub Transition Project - £90k + £30k = £120k

Providing a pathway for those in hardship and associated food poverty to help support and empower their move from dependency to self-reliance. In partnership with John Storer Charnwood and the Charnwood Food Poverty Group, individuals will be offered support from the Community Hub and transition into the Community Hub Shop once up and running. This would provide access to lower priced food alongside other services such as money management advice / financial literacy classes, access to debt advice, access to a credit union, job and volunteering advice and basic cookery classes.

Food Support - £50k

To provide food for those in hardship through food parcels, FareShare Membership, the Community Hub Shop and hot food and daily food bags for those of No Fixed Abode / temp accommodation. To include emergency support to Clinically Extremely Vulnerable residents and those that have specific dietary requirements.

Voluntary & Community Sector (VCS) Covid Support - £30k

To support VCS Covid activity in the community to include local projects addressing specific community need eg: working with the local BAME community and grass roots projects, Befriending and Mental Health support projects, along with services to support the Community Hub project.

Health Promotion - £25K

Promotion of preventative physical and mental health interventions, linked to Leicester-Shire & Rutland Sport Active Together messaging and resources aimed at general promotion and targeted (hard to reach groups, CEV, BAME population, vaccination centres, testing centres, businesses) and including specific one to one support through volunteering and Get Active schemes, including physical activity packs.

Community Support - £18k

Additional Neighbourhood Development Hours to provide additional community based support for those areas disproportionately impacted such as BAME / deprived communities — to assist with vaccine hesitancy work, plus targeted interventions for these specific sections of the community.

Community Hub Transition Spoke Development - £30k

To support the expansion of the Community Hub transition model to develop spokes at other food bank locations throughout the borough to enable easy access by residents. The proposal is for those currently receiving parcels from the food banks to move towards membership of the Community Hub Shop (social supermarket)

accessing subsidised food. A hub and spoke model is being proposed which will create similar access in other areas of the borough including community pop up shops. The first steps will be to assess those currently being supported through the local foodbanks and for those that meet the criteria to be moved into membership of the Community Hub Shop.

The funding will enable a Pop Up Tool Kit to be provided (Spoke model) to include marketing and merchandise, food storage to include thermal chill boxes and racking etc plus wifi tablets for processing of details and access to the database. In addition, the funding will support the Community Hub and Spoke Model marketing and merchandise and production of membership packs.

Charnwood Food Poverty Group (CFPG) Support - £20k

To provide funding to support the work of the CFPG, which is all externally funded, who have been working as part of the Charnwood Community Action Hub and are actively involved in the Community Hub Transition project, are lead on co-ordinating the work of the group and developing the Spoke element. This will go towards funding the continuing of the CFPG Development Officer, as well as covering FareShare Membership for other food banks, equipment, training and running costs

Housing Advice and Homelessness – £39.6k

The Housing Options Team has seen an increase in case loads during the COVID-19 pandemic. Further increases in case loads are expected over the coming months, particularly relating to an anticipated increase in the loss of Assured Shorthold Tenancies in the Private Rented Sector (the suspension of evictions expired on the 31st May 2021).

The recruitment of an additional temporary Housing Options Officer will ensure that there are sufficient resources within the Housing Options Team to manage the anticipated increase in applications.

Prevention and Accommodation Pot - £103.1k

Funding available for preventing homelessness and alleviating immediate hardship, and provision of accommodation and transport costs.

Housing Allocations and Lettings - £28k

The Council has seen an increase in Housing Register application during 2020-2021 due to increase in housing issues and homelessness resulting from the factors associated with the COVID-19 pandemic, such as loss of employment, tenant rent arrears and landlord mortgage arrears.

The recruitment of an additional temporary Assistant Housing Officer will ensure that there are sufficient resources within the Housing Allocations and Lettings to manage this increase in applications.

Public Health Funerals - £22.5k

The Council has a statutory duty to deliver and fund public health funerals. During the COVID-19 pandemic the Council has seen a significant increase in the number of deaths, where the deceased has not had a next of kin or finances for a funeral to take place.

Enhanced Targeted Communication/Marketing £18.8k

The Council has commissioned some external support to support communications with seldom heard groups in the short to medium term. This is to help share information relating to the pandemic and gather insight. This work includes create a stakeholder database to improve engagement with different groups and communities; engagement with seldom heard groups to better understand community issues in light of the pandemic; creation of a diversity/community panel to better understand community views.

£20,000 is also being used to extend a contract for a senior communications officer to help the communications cope with demand caused by the pandemic.

Engagement and Communication Support - £40k

The Council's Communications Team has been under significant pressure since the start of the pandemic and this is expected to continue for some time as the pandemic continues to play out and the focus switches to recovery. There is also the prospect of further outbreaks, particularly in the winter months. Half of this funding has been allocated to support vaccination engagement with seldom heard groups; create a stakeholder database to improve engagement with different groups and communities; engagement with seldom heard groups to better understand community issues in light of the pandemic; creation of a diversity/community panel to better understand community views.

The other half of the funding has also been allocated to extend the contract of a temporary senior communications officer to support the work of the communications team.

Communications Support - £41k

Due to the ongoing pressures on the communications team, a temporary post of a Senior Communications Officer has been agreed to provide extra capacity to deal with the workload created by the pandemic, the recovery and build in extra resilience until the end of March 2022. This includes demand on internal and external communications.
