#### Reason

The S106 Agreement is required to make the development acceptable in planning terms, to ensure an adequate biodiversity compensation will be secured either on site, or of that so not achievable in whole or in part, off site bymeans fo funding to the Council in order to facilitate the provision of necessary and adequate compensation elsewhere.

Also, to ensure funds are made available for bus passes for future employees on the site, in order to encourage and support sustainable travel options. This is in conjunction with conditions requiring a Travel Plan and an funding towards the monitoring of its implementation and effectiveness.
