#### Recommendation

That a Section 106 Agreement be signed to secure the following planning obligations under Planning Permission reference P/22/1171/2:

- 100% Affordable housing on the site to be let by a Registered Provider to households who are eligible for social rented housing or no less than 30% (67% social rented 33% shared ownership).
- The provision of offsite open space contributions:
  - £2,033.00 for Allotment provision or enhancements, contribution
  - o £4,092.00 for enhancing natural and semi natural open space
  - £5,900.00 for Outdoor Sports Provision
  - £5,880.00 for Parks and Amenity Open Space
  - £4,800.00 for Childrens play facilities
  - £17,171.00 for Young Persons Contribution
- Offsite impact compensation for biodvisierty to be purchased by the applicant from the habit bank of 0.09 habitat units as measured by DEFRA metric, with written confirmation of the purchase to be submitted prior to the commencement of development.

County Council contributions for:

- Bus Pass contribution for a six month period £18,792.00 (£1044.00 per dwelling)
- o Travel packs £951.30 (£52.85 per dwelling)
- Library contribution of £422.77 towards Loughborough Library
- Healthcare Contribution:
  - £8,695.30 for increasing patient capacity from the development at Pinfold Medical Practice or Park View Surgery

The S106 agreement will be required to enable the grant of planning permission, as per the Plans Committee resolution:
