### <u>Important – please read carefully</u>

Please complete the Notice in black ink or typed in a font of a size equal to or larger than 16 – this Notice is in a font of size 16. Please note that the words which form the heading of the Notice must be in a font size equal to or larger than 32. The remainder of the Notice must be in a font size equal to or larger than 16.

The Notice must be of a size equal to or larger that A4. This Notice is size A4.

The Notice must be printed on white paper.

The Notice must be displayed prominently at or on the premises to which the application relates where it can be conveniently read from the exterior of the premises and if any part of the external parameter of the premises that is 100 or more meters in length abuts a public highway or other place accessible to the public, by displaying such a notice at least every 50 meters along that part of the perimeter.

The Notice must be kept on display for a period of no less than 10 working days starting on the day after on which the application was given to Charnwood Borough Council.
