### **Charnwood Local Plan Main Modifications consultation response**

Thank you for consulting Historic England on the Main Modifications.

**MM24, Policy DS1** The changes agreed through the Statement of Common Ground have not been made. Historic England is of the view that Policy DS1 is not sound at this time. The environmental section of the policy currently reads 'should conserve and enhance the built and natural environment'. In this respect the potential requirements for any buried archaeology, designated or non-designated, is not addressed within the policy. As such, the policy does not reflect the requirements of the NPPF, including footnote 68. It was agreed within Appendix B of the SOCG that '*natural, built and historic*' would be substituted for '*built and natural*'.

Similarly, the changes agreed to paragraph 3.84 through the SOCG have also not been implemented through the main modifications.
