Charnwood Borough Council, in exercise of the powers conferred on it by the Section 83(2)(b) of the Environment Act 1995 HEREBY makes the following order:-

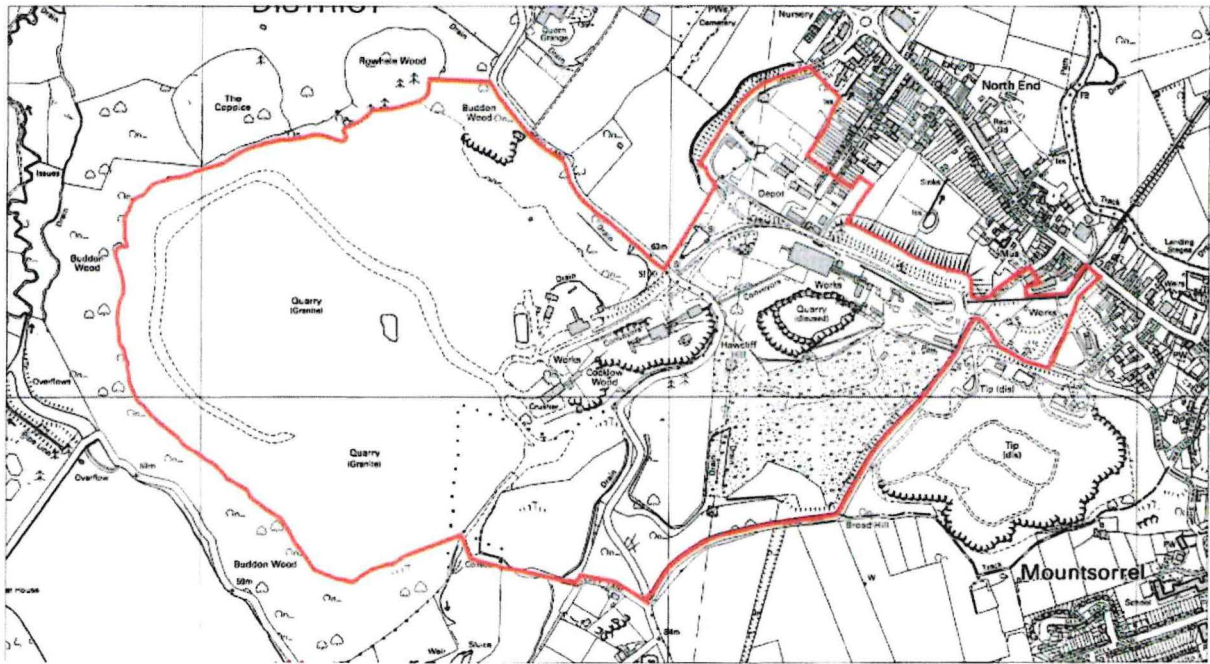

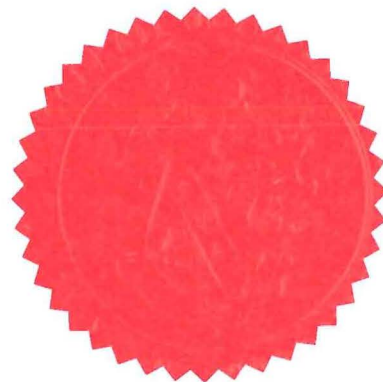

**REVOCATION OF GREAT CENTRAL RAILWAY AIR QUALITY MANAGEMENT
