RESOLVED

- 1. that, in respect of application P/18/0309/2 (David Wilson Homes (East Midlands), Land off Barkby Road, Queniborough), planning permission be refused for the reasons set out in the report of the Head of Planning and Regeneration;
- 2. that, in respect of application P/18/0435/2 (William Davis Ltd, Land off Tickow Lane, Shepshed), planning permission be granted subject to the condition set out in the report of the Head of Planning and



Regeneration as amended in the Additional Items report to reflect the most up to date set of plans submitted by the applicant;

- 3. that, in respect of application P/18/0373/2 (Mr and Mrs Musson, 47 Toller Road, Quorn), planning permission be refused for the reason set out in the report of the Head of Planning and Regeneration;
- 4. that, in respect of application P/17/2326/2 (Mr Syedur Rahman, 3 Victoria Street, Thurmaston), planning permission be refused, contrary to the recommendation of the Head of Planning and Regeneration, for the following reasons:
 - notwithstanding the relatively sustainable location of the application site and the traffic which the authorised business use could generate the adverse impact of the proposal outweighs the benefits arising from the development;
 - the provision of inadequate car parking spaces would result in additional on-street parking in an area where there are already parking problems; this would be to the detriment of highway safety and local amenity, contrary to saved Local Plan Policy TR/18.
